 Gold Star License Plate Verification**

During the 1st Regular Session of the 60th Idaho Legislature, HB24 was passed, allowing for the issuance of Gold Star license plate for spouses, parents, and other immediate family members of military service members killed by hostile action during active military service in a period of war recognized by the United States Congress. "Gold Star Family" license plates are being adopted across the United States to recognize the sacrifice of families when a service member is lost during a military conflict. Surviving spouses and parents of deceased service members will not pay the specialty plate fees for gold star plates. A portion of the fees paid by other qualifying relatives will be used to defray the costs of administering the issuance of the plates at the Department of Transportation and the Division of Veterans Services. Any remaining fees will be used to provide support programs for veterans.
