Approval of Minutes

Acting Chairman Cash asked for a motion to approve the minutes of the previous meeting on April 20, 2023. **Commissioner Brown** motioned for approval. **Commissioner Davis** seconded. The motion was approved with unanimous assent.

Community Outreach – presented by Mitzi Cheldelin

Spoke about her outreach efforts around the state working with Veterans Service Organizations and community members to serve Idaho Veterans. Between April 1 and June 30, Mitzi has connected with 875 Veterans, 104 Civilians, and 4,115 mixed groups across 69 events in 13 counties.

Major Events during this past quarter:

- Memorial Day Ceremony at the Idaho State Veterans Cemetery in Boise was attended by 900 visitors with collaboration from over 40 organizations.
- The first Idaho Women Veterans Conference since CoVID was a success. Over 80 women participants attended with both inspirational and educational presentations hosted by the Warhawk Air Museum. Exploring hosting a conference annually the Saturday prior to June 12th, which is Women's Veterans Day. Also looking to add a telecast option to expand this event statewide for attendees unable to travel.
- In April, the General Consul from the Republic of South Korea visited Boise to present our living Korean War Veterans with Ambassador of Peace Medals. Also placed a wreath at the Idaho State Veterans Cemetery in Boise to honor Korean War Veterans no longer with us. Hosted a luncheon with Korean War MIA families.
- The Wall that Heals, a ¾ scale replica of the Vietnam War Memorial Wall in Washington DC, came to Idaho.

It was displayed 24/7 over a 5-day period. Over 15,000 visitors viewed it at all hours of the day and night. According to the organizers turnout was unprecedented for a community the size of the Treasure Valley.



Special Highlight

A woman in Savannah, Georgia, who's husband served w/ a Veteran located in Idaho was concerned about the struggles and addiction issues the Idaho Veterans was suffering. She posted in a national group seeking assistance. A retired Idaho National Guard member currently living in Mississippi helped connect her with resources in Idaho. Mitzi connected the Idaho Veteran in need of assistance with Mission43 Project Resilience. Mission43 Project Resilience was able to get the Veteran into a long-term rehab program located in Texas and is paying for the treatment. Local Veteran Service Organizations stepped up to get his back rent and past due bills paid. They also were able to get his dogs boarded/fostered with a local family.

Division Bureau Reports

HR Report presented by Angela Hamilton

HR Modernization – All human resources staff were successfully transferred from IDVS to DHR on June 11, 2023. The staff will remain in our facilities but will be under DHR leadership.

Luma – Luma was implemented on June 20, 2023. There have been some technical issues with the Human Capital Management piece of the system that all HR staff are working hard to identify and correct with assistance from the Luma team.

Currently working to update the IDVS Personnel Policies and Procedures, as well as the IDVS Supervisory Handbook.

Comparing the 4th Quarter FY-2023 to 4th Quarter FY-2022, resulted in 294 additional office interviews, 1,279 additional phone calls, 880 additional claims filed, and 378 additional pieces of claims correspondence filed to the VA.

Noteworthy Issues Currently Happening with the VA

 Boise VA Regional Office is continuing to hire new employees as part of the VBA Expansion due to workload increase due to the PACT Act.

- Since the VA began accepting PACT Act Presumptive claims, the VA (Nationally) has received 722,654 claims with 394,782 still pending. Of the pending, 136,700 are in backlog status. Idaho Pact Act Claims submitted total 4,554.
- - Veterans have until August 19, 2023, to submit a PACT Act claim to have it back dated to August 10, 2022 as the effective date.
- Camp Lejeune Justice Act (Contaminated Water Lawsuits) have until August 9, 2024, to submit a claim.
- Boise VA Regional Office will be hosting a PACT Act Claims Clinic in Pocatello in September. They will be
 asking for our help to advertise the events and to see if we would like to participate.
- VA increase the Award Rate for Non-Service-Connected Burial Benefit to \$893.00. The Plot Allowance Rate is \$893.00 if a Veteran is interred in a private cemetery. The VA is also paying transportations costs that are identified on the Itemized Funeral Bills. Service-Connected Burial Awards will also pay the transportation costs on top of the \$2,000 award.

Significant Events within the OVA

- We will be conducting the Annual County and Post Service Officer Training at the Riverside Hotel from August 16-18, 2023.
- VFW will be conducting their Annual Skills Level Training in Annapolis, MD September 10-14.
- The 2023 Idaho Women Veterans Conference was conducted at the Warhawk Museum on Sunday, June 11th with approximately (40) in attendance.
- OVA will be announcing a new VSO position for the Boise VA Regional Office soon. We are working with the Boise VARO to modify our office layout to permit an additional cubicle.
- The new **Quarterly OVA Bulletin** should be released within the next week or so.
- OVA has been participating in many outreach events to include the Idaho National Guard Family Day at Zoo Boise, AARP Idaho Town Hall, Lion's Club, National Guard Pre-Retirement Events, etc.


FY23 YTD Nursing Occupancy Rate



Nursing Yearly Costs Comparison per Resident Day



Construction Grants Update presented by **Tracy Schaner**

IDVS received a grant award letter for the Boise Home Replacement Project. We have accepted the conditional grant award.

Construction will begin spring/summer of 2024.

Boise Veterans Home Report presented by **Rick Holloway**

The final WWII Veteran residing in the Home passed away a few weeks ago. This was a long-time resident who lived most of their life in the Dom/Res.

Boise identified an error in the submission for a 5-star CMS facility.

The Public Health Emergency has lapsed.

Currently working to place residents from the domiciliary in other, safe living arrangements. Boise is ceasing it's

Dom/Res program because the VA Dom/Res reimbursement doesn't cover the cost of operating the Dom/Res program.

DPW & Maintenance Projects:

- 20-604 Replace/Install Parking lot drains began in May, ongoing.
- 21-606 Phase II of screening facilities. Discussion has begun with some minor changes to the locker room and outside surrounding entrance/concrete work. Construction has not begun but is anticipated to take 1-2 weeks when it does begin.
- 22-600 Boiler and Chiller Replacement ongoing with some concern for warmer temperatures, placing emphasis on maintaining our current cooling system until this project can be completed over the next 18 months.

Significant Community Support and Activities

- Texas Roadhouse in Pocatello sponsored dinners for our residents over the last few months. We took several small groups and brought take-out for residents who weren't able to go.
- Volunteer staff from the ISVH-Pocatello participated in the 2023 Portneuf Valley Paintfest starting on June 19. Teamed up with Simplot and Simplot Credit Union to prep and paint a single level house. The homeowner was thrilled with the results.
- Received a grant from the Idaho Commission of the Arts to create an Art Club over the winter. The group
 culminated with an Art Reception with artist Bob Beason. We served appetizers and displayed artwork for
 the reception.
- We were visited by Marine Veteran, Scott Montefusco, on his Great American Road Trip (GART)! Our Veterans got a chance to check out his 1952 WWII Willy's Jeep and visit with Scott and local Veterans who came by to join the fun.

Education Report presented by Paul Spannknebel

FY2023 Allocation:

Received \$55,379.21 on May 30th for the 2nd Quarter VA reimbursement.

The 3rd Quarter reimbursement is due to the VA no later than August 18, 2023. It will be submitted to the VA once the final June pay period is released July 21, 2023.

COLA modification was approved by the VA in mid-March 2023. It will increase the FY23 Allocation from \$172,480

to \$187,486.

FY22 Supplemental budget request of \$79,189.31 was approved by the VA on June 12, 2023, can expect the disbursement in early 2024, possibly earlier.

- Program withdrawals

While 19 poor or low performing facilities were withdrawn in Q4, the number of programs approved grew due to existing and new facilities adding additional quality programs for veterans and beneficiaries to choose from.

Current Projects in Education

Continued to focus on reinforcing timely submission of reapprovals for IHLs and NCDs. The education team is accountable to VA for timeliness, we are extending that accountability to the facilities themselves.

Team focused on increasing productivity in 2023 achieving a 99% reporting net increase in Idaho SAA productivity from this same time last year. In 4th Quarter FY2022, the education team responded to or participated in 23 various technical assistance requests, outreach, liaison, and training opportunities. In 4th Quarter FY2023, the team responded to or participated in 137 technical assistance requests, outreach, liaison, and training opportunities.

Continue to work actively with ITS project team to create IDVS education's first database and ap (power pages) to house facility information and workflows.

Training our TRS1 is dialing down. Wendy's probationary period will end in July; she has proven herself an asset for the team.

Assigned 8 RBS (Risk-Based Surveys)

- 4 IHLs and 4 NCDs
- 50% of assigned facilities submitted to VA by the end of the (VA's) Q3
- 100% of the assigned facilities have been visited.
- Working to collect remaining RBS materials from school and submit final reports to VA by end of VA's Q4 (September)

FY23 Risk factor identified 8 Idaho facilities:

- 3 facilities with 85/15 program violations
- 4 facilities with 30% increase in tuition and fees from academic year '21 to academic year '22
- 1 persistence rate more than 55%
- We withdrew 2 NCD facilities (and their programs)
- One NCD school's RBS resulted in \$68K in overpayments to the school. This school elected to voluntarily withdraw their programs' approvals.
- We withdrew 1 IHL facility (and their programs) and approved 2 new IHL school (and their programs) for GI Bill® in Q3.
- A private, nonprofit IHL was referred to VA for a TRBR, Targeted Risk Based Review, due to multiple risk factors discovered during the RBS conducted by the Education team.

Business Support Report presented by Paul Spannknebel

Reiterated implementation pains regarding the Luma launch. Our staff are working hard to smooth the process when possible and identifying issues outside of our control to the statewide Luma team for resolution.

IDVS is hiring a Business Analyst to better liaise between IDVS and ITS to better serve the Agency and our programs.

Central Support Office Updates

<u>Chief Administrator's Remarks</u> presented by Mark Tschampl

Continue to focus on outreach.

Receiving calls from his counterparts in other States inquiring how they can replicate programs Idaho has launched such as the online Idaho Veterans Resource Guide, project to identify all Veterans in state, a potential project to utilize ai to process data to connect Veterans at high risk for suicidal ideation to life saving resources.

IVAC Meeting Minutes 07-12-23.

Looking at ways to increase access to dental care for Veterans to address shortfall from the VA.

Staffing

Agency has had success in finding high quality team members to fill vacancies across our programs.

Our ability to offer scheduling flexibility has proven successful in attracting and retaining hard to fill nursing positions. (Three 12-day shifts for a 36-hour work week but maintaining the same pay as a 40-hour work week).

New Business

Discussed having the next IVAC meeting at one of the state Veterans Homes. After discussion decided to host the October IVAC meeting at the Pocatello Home. Tentatively scheduled for October 26.

Acting Chairman Cash is open to a motion to adjourn. **Commissioner Davis** motioned to adjourn at 11:20 AM MT. **Commissioner Brown** seconded. The motion was approved with unanimous assent.
